2. All accounts are due and payable by the **25<sup>th</sup>** of the month following invoice date. All amounts not received on or before the **25<sup>th</sup>** are past due and are subject to a service charge amounting to 1 ½ % per month 18% per annum.
3. All invoices are deemed correct unless Peninsula Building Materials Co. receives written notice of dispute within 30 days of invoice date.
4. In the event of a suit, applicant agrees to pay cost of collection, including attorney's fees.
5. All persons further agree that in the event legal action becomes necessary, the same will be filed in San Mateo County unless otherwise prescribed by California Mechanics Lien Law.
6. Applicant will provide seller, upon request, complete job information on all orders of \$1000.00 and over for the purpose of preparation and service of a Preliminary 20-day Notice under applicable mechanics lien laws.
7. Those persons signing this agreement **INDIVIDUALLY** and as officers of the corporation applying herein, do hereby agree to the terms and conditions of this contract and hereby **INDIVIDUALLY** bind themselves and the corporation to the terms and conditions of this contract; and guarantee the payment for all material and services purchased pursuant to this agreement.
8. All payments to be applied as directed by customer. If no direction is given at time of payment, Peninsula Building Materials Co., reserves the right to allocate payment to the oldest outstanding customer invoices.
